This request is to provide additional matching funds for federal energy conservation requirements at the Kodiak Army Guard Facility. The funding ratio for the Kodiak Armory has changed due to federal regulations regarding funding and armory use. The general fund match required for this project is now \$2,500 more than appropriated. This amendment increases the general fund match by the \$2,500 required and reduces the federal amount by \$2,500.

Project Description/Justification:

Due to the state to federal funding ratio change, the amount of state match for this project has increased from 25% state/75% federal to 50% state/50% federal.

The project scope remains the same: Funding is requested for energy upgrades in the Kodiak Army Guard facilities. This funding request takes advantage of federal funding opportunities that are available to renew Army National Guard facilities, reduce deferred maintenance, and lower operational costs. The replacement of exterior lights with LEDs at the Kodiak Armory works to reduce operating and maintenance costs and increases lighting at the armory. Priorities and cost estimates may need to be changed to accommodate emergency maintenance projects not listed, actual project costs, and other considerations.
