Project Description/Justification:

The Alcantra Complex has been identified as a command center and forward operating location in the case of a statewide or national disaster. The Department manages 320 acres at this location which is being developed to accommodate military training, regional emergency services, and other State services.

The vehicle storage area is in disrepair and not compliant with Army National Guard security standards. Vehicle storage areas need to be lighted and fenced. Head bolt heaters are needed to ensure fleet operations in severe weather, especially in the event of an emergency.

This project will allow the storage yards to adequately accommodate the assigned military units, the forward operating location for disaster preparedness, and the storage of State of Alaska vehicles, equipment, and supplies. Upgrades will include gravel, fencing, lighting, and power drops. Federal funding will not pay for state storage upgrades and general funds are requested to allow for the most cost effective way to meet federal and state storage needs. The weapons storage vaults need to be upgraded to current standards.

Priorities and cost estimates may need to be changed to accommodate emergency maintenance projects not listed, actual project costs, and other considerations.
