Brief Summary and Statement of Need:

The Alaska Public Safety Information Network (APSIN) contains criminal history information used by law enforcement agencies across Alaska. It is a major tool used in meeting the department's mission of protecting the public. This has been an ongoing, phased project to move APSIN from the State of Alaska legacy mainframe to a Microsoft and Intel server platform, and at the same time enhance the Alaska Public Safety Information Network's capability. This project will use contracted professional services to provide support during the transition from the mainframe and support new initiatives until skilled employees can be hired to maintain these systems.

Contracted services will be utilized to maintain older legacy APSIN code, provide support to highway safety statewide law enforcement program development, and continue progress on new APSIN. They will also continue the Traffic and Criminal Software (TraCS) help desk support.

The department is recruiting to fill vacant positions with qualified personnel to support the newer technologies. In the interim, contracted support has been identified as the most prudent method to complete a variety of projects that require these high level of skills. Once operational, existing and new state programming staff will maintain the new APSIN projects.
