**Project Description/Justification:****Motor Carrier Safety Assistance Program (MCSAP) - \$985,000 (FMCSA 80% / State Match 20%)**

The MCSAP is a federal grant program that provides financial assistance to states to reduce the number and severity of accidents and hazardous materials incidents involving commercial motor vehicles (CMV). The goal of the MCSAP is to reduce CMV-involved accidents, fatalities, and injuries through consistent, uniform, and effective CMV safety programs. Investing grant monies in appropriate safety programs will increase the likelihood that safety defects, driver deficiencies, and unsafe motor carrier practices will be detected and corrected before they become contributing factors to accidents.

The MCSAP also sets forth the conditions for participation by states and local jurisdictions and promotes the adoption and uniform enforcement of safety rules, regulations, and standards compatible with the Federal Motor Carrier Safety Regulations and Federal Hazardous Material Regulations for both interstate and intrastate motor carriers and drivers.

Grant funding to improve safe and efficient operations by providing additional safety enforcement from Alaska State Troopers and area police departments. Includes training and purchasing essential equipment.

Funding is requested to:

- Assist Alaska State Troopers in CMV enforcement in Fairbanks, Kenai Peninsula and Matanuska-Susitna Boroughs
- Train and equip five local Police Department officers in Hazmat and Cargo Tank Inspection
- Fund Alaska State Troopers CMV enforcement efforts on the Haul Road
- Purchase of protective jackets/vests for CVE Officers
- Training of Measurement Standards & Commercial Vehicle Enforcement (MSCVE) staff in use of FMCSA suite of inspection software
- Purchase CVE gear for ten NAS Level 1-trained police officers
- Data quality improvement

### **Border Enforcement Program - \$540,000 (FMCSA 100%)**

Increase border safety and security activities to reduce fatalities and injuries from crashes involving Commercial Motor Vehicles. Increase safety inspections of international Commercial Motor Vehicles at ports of entry throughout the State.

Alaska shares five road border crossings with Canada. With open borders and international shipments increasing every year, increased safety and security checks of commercial motor vehicles is more important than ever. Via the continued operations of the Borders Enforcement program, CVE is working to increase the safety and security of international shipments and overall trucking safety by implementing programs to increase the number of international commercial carrier, vehicle, driver and cargo inspections entering and departing Alaska.

Border Enforcement funds are used to train and equip personnel for the Drug Interdiction Assistance Program. The purpose of these funds will be to familiarize necessary personnel with current drug trafficking trends and smuggling patterns, bulk drug movement indicators and detection methods, indicators of a driver using, possessing, selling or hauling illicit drugs, commercial vehicle search techniques and characteristics of impaired drivers. This is to provide law enforcement personnel with the means to better identify and apprehend transporters and users of illicit drugs and to remove impaired and unqualified drivers of commercial vehicles.

This project contributes to the Department's Mission by reducing injuries, fatalities and property damage.
