**Project Description/Justification:**

This project continues the acquisition of land for a veteran's cemetery in Interior Alaska. This will provide a dedicated State Veterans Cemetery in the Fairbanks region to serve the burial needs of veterans in the interior of Alaska. Currently veterans in this region must travel to Anchorage or Sitka, 350 and 750 miles respectively, to reach the nearest veterans' cemetery with available grave space.

This project was originally to be developed on donated land, but the amount of permafrost and poor sub-soils on the proposed location made the site unsuitable for construction. The Department of Military and Veterans Affairs also assessed available state land in the region, but could not find land that would support cemetery development. There is currently \$7 million in federal authority and \$1 million in state funds budgeted for the planning and development of this project.

This project supports the Department's mission by supporting veterans and military families.
