**Prior Funding History / Additional Information:**

Since 1999, The Department of Military and Veterans Affairs has collected \$798,587 in federal revenue for CDSP's Drug Interdiction and Civil Operations programs.

**Project Description/Justification:**

Federal receipt authority is requested to allow the Counterdrug Support Program (CDSP) to receive forfeiture funds as a result of Alaska National Guard assistance in drug investigations. These funds are expended in accordance with the U.S. Department of Justice's guidance, providing the program with technological support, supplies, and facility improvements.

Alaska operates a joint CDSP that is comprised of both Army and Air National Guard members. Programming encompasses two critical areas: Drug Interdiction and Civil Operations. Drug Interdiction provides operational resources in drug investigations across Alaska. The program supports federal, state, and local law enforcement with manpower, equipment, a scent detection canine, and logistics. Civil Operations (formerly Drug Demand Reduction) provides drug education and positive life skills curriculum to Alaska youth in urban and remote communities.

This program contributes to the Department's mission by defending and protecting Alaska and the United States and providing youth intervention.
