The Pioneer homes all operate on a 24-hour basis, have a cumulative square footage of about 450,000 square feet, and have a combined replacement value of \$334,000,000. The facilities have deferred maintenance needs resulting from heavy usage by staff and residents. This project for funds will address only the most critical of the prioritized needs in order to maintain the State's investment in the department's facilities. The homes have a combined capacity of over 600 residents.
