This project will address significant code compliance issues within the existing aircraft hangar (10,000 sq. ft.) in Bethel. The list of required repairs is based on a spring 2011 engineer's report. This project will begin to address a multitude of electrical, mechanical, heating and energy repairs needed in the hangar. Providing the required maintenance will avoid complete replacement of the hangar.

Project Description/Justification:

Bethel has been and will continue to be the main support hub for the state to provide many mandated and essential public safety functions, such as ensuring public safety and enforcing state laws by protecting lives, public peace, and wildlife resources.

Currently, the state operates out of a 30 plus year old hangar that was not properly constructed. The main support beams are on pilings that have shifted so much over time it has caused them to twist and buckle. The state keeps four aircraft and some of its search and rescue equipment in this hangar. In addition, the Civil Air Patrol has two airplanes and office space for their squadron. There is inadequate space for storage of fuels and oils and miscellaneous parts that accompany this fleet of aircraft. The existing hangar is structurally damaged and lacks many basic features, such as a restroom or water.
