This annual project provides deferred maintenance funding for Department of Public Safety state-owned buildings throughout Alaska. The department occupies various facilities in 66 statewide locations with a number of electrical/mechanical code issues, as well as energy and security improvements that need to be addressed. Storing evidence, protecting department-owned equipment, and providing employees with good working conditions allows the department to meet its mission and accomplish stated results.

Project Description/Justification:

This project is for corrective and preventative maintenance and improvements at state-owned facilities in locations throughout Alaska. Facilities include both Alaska State Trooper and Alaska Wildlife Trooper posts and aircraft hangars, housing facilities, and evidence storage areas.

Many of the department's facilities are becoming increasingly maintenance-intensive as they age; some facilities are more than 30 years old. Funding for regularly scheduled preventative

maintenance, as well for emergency repairs, is essential to keep these facilities useful or even habitable.

Priorities and cost estimates frequently change to accommodate emergency maintenance projects. The department can provide a facility maintenance list of over \$6 million in various projects of which this capital request will go towards the most critical. Examples include electrical and mechanical code compliance issues, along with energy and security improvements. Mostly general allocations are established for this project in order to keep the project administration flexible for the department to adapt to changing conditions (e.g. weather or personnel can delay a project).
