the below types of equipment; however, other types of equipment may be purchased if deemed more mission critical.

New and replacement electronic and office equipment: \$100,000

This category of equipment includes digital cameras, computers, scanners, printers, and video and office equipment for use in crime scene documentation and evidence gathering. This category also includes the replacement of antiquated and irreparable office furniture.

Law enforcement equipment: \$300,000

This includes the replacement of aging equipment used in search and rescue missions as well as fisheries and wildlife patrols. Types of equipment include global positioning units, radars, snowmobiles, all-terrain vehicles, outboard motors, and trailers. This category includes tasers and firearms and other uniform items.
