**Project Description/Justification:**

The Dillingham area is a jumping off point for travelers visiting remote lodges in the surrounding area and the many lakes within the Wood-Tikchik State Park. The existing float plane facility, Shannon's Pond, provides a 1,400 foot by 100 foot waterlane for use during visual weather conditions. It has ten based single-engine aircraft and while the facility is open to the public it is owned by a private individual. The Choggiung Corporation owns land near the pond and is beginning to make plans for improved floatplane facilities. A planning effort is needed to ensure that public interests are protected as aviation related development occurs within the region. The Dillingham Regional Airport is located within one mile of Shannon's Pond and participation is necessary to minimize future airspace operation conflicts.
