Improve surface access between Juneau and both Haines and Skagway through construction of a new 50 mile highway extending Glacier Highway from Cascade Point to a new ferry terminal north of the Katzehin River delta.

Total project cost is estimated to be \$520,000,000. Future appropriations will be a blend of state and federal funds. The SLA 2004 appropriation is federal receipt authority - all other prior appropriations are general funds.

**Project Description/Justification:**

The department identified a preferred alternative in the final environmental impact statement (EIS) released by FHWA in 2006, and obtained a Corps of Engineers permit in 2008. The highway will extend from the end of the recent Glacier Highway extension at Cascade Point to a terminus north of the Katzehin River. From there, shuttle ferries will provide connections to the road system in Haines and Skagway. A court ordered supplemental EIS is anticipated to be completed in January 2014. Construction could begin as early as Spring of 2014.
