Project Description/Justification:

The new Reservations Manifest System will have all functionality of the current Reservations Management System (RMS), plus the following additional features:

- Assist marketing personnel in attracting a larger ridership to the ferries to improve the operations revenue so that the state subsidy can be reduced.
- Improve vessel space utilization.
- Extend the reach of the RMS onto the vessels to reduce manual ticketing and improve information flow between the vessel and shore operations.
- Improve public access to the reservations system through a more user friendly web interface and stand-alone kiosks in remote locations without AMHS staff.
- Allow 2nd tier marketers direct access to our reservation system.
- Direct production of all reports required by legislatively mandated Annual Traffic Volume Report.
- Provide for extracts of data or reports necessary to meet department required inputs for a performance monitoring system.
- Add detailed manifesting capabilities to meet security requirements imposed by the U.S. Coast Guard and the Department of Homeland Security.
- Allow ad hoc queries of previously unthought of dimensions to system data.
- Make use of developing satellite networking capabilities being installed on AMHS vessels.
