Along with the setting tank - the City would like to replace the outfall line to ensure the system runs as it was designed to and does not leak any excess waste into the surrounding waterways which could create a hazard to the community. Right now the City of Angoon is violating its waste permits due to old/eroded outfall lines. To ensure the safety of the community and surrounding environment this tank system will need to be replaced to ensure the long-term safety of the community.

WHEREAS, the City of Angoon has an opportunity to have some of these needs met by direct appropriations of funds from the State of Alaska; and




