 Association funds upgraded all heating, plumbing system as well as septic upgrade and insulated wellhouse.

Detailed Project Description and Justification:

Current buildings are attached military steel buildings with minimal insulation and cannot be further insulated from the interior. Licensed contractors advised spray coating building with 2" of urethane foam and a protective coating. Four uninsulated doors would be replaced and an arctic entry storm front constructed on the main entrance.

Recent annual heating bills have approached \$8,000 and anticipated savings would be \$6,000 per year based on \$4 heating oil costs.
