This project provides new and replacement law enforcement equipment for use by the Alaska Wildlife Troopers. Equipment replacement is due to normal wear and tear. The list below includes some examples of equipment needs; however, other law enforcement equipment may be purchased if deemed more mission critical.

Examples include: global positioning units, radars, snowmobiles, all-terrain vehicles, outboard motors, trailers, tasers, firearms, digital cameras, computers, scanners, printers, irreparable office furniture, search and rescue equipment and any replacement equipment for fisheries and wildlife patrols.
