Brief Summary and Statement of Need:

The state maintains approximately 253 Rural System airports. The surfaces on these airports are continuously degrading, due to time, use, settlement, wind and water erosion, moisture accumulation, and vegetation growth. Many of these airports are substandard and need minor surface improvements to improve their safety and capacity. The department has an active program to maintain and preserve paved surfaces to slow their rate of deterioration and extend the pavement life to defer the need for high cost pavement replacement.
