Brief Summary and Statement of Need:

This project will upgrade the fencing and gates around the Air Operations Area (AOA) Part 139 airfield to become 1542 compliant and remain 139 compliant. It may also upgrade non-compliant doors in Fairbanks International Airport (FAI) facilities. Upgrades will include replacing deteriorated fencing and substituting non-compliant remote gates with card access gates.

No prior funding history

Project Description/Justification:

The perimeter fences and gates around the AOA are deteriorating, i.e., rust and upheavals from permafrost, and need replacement. This project includes upgrading gate controllers with access controlled gates and CCTV that is controlled by Dispatch. Additionally, FAI recently had a civil penalty enforced by the TSA for non-compliant gates. A portion of the Airport's response to the civil penalty was tied to this project, specifically, security improvements to the gates.

The fencing and gates for Part 139 were erected over the course of many different years and through various projects. Some of the fences and gates are showing signs of wear, maintenance issues, and pose security concerns. If the secure perimeter of the Airport or its facilities deteriorate to the point that the secure area is not in compliance with Part 139 or Part 1542 the airfield could be closed and airport subject to continued penalties.
