Brief Summary and Statement of Need:

The National Historic Preservation Fund (NHPF) is a federal program to assist states with their statewide historic preservation programs. The NHPF fund is used for grants to local governments, agencies, organizations and individuals for restoration or stabilization of historic properties, and grants for survey, inventory, education, planning and training projects. Included in this capital project are cooperative historic preservation projects executed through cooperative or assistance agreements or grants with federal agencies. Cooperative historic preservation projects with federal agencies help meet mutual cultural resource management goals.

Project Description/Justification:

This project has leveraged federal funds for historic preservation projects since 1972 by making grants to local governments, agencies, organizations and individuals for restoration or stabilization of historic properties, as well as for survey, inventory, education, research and planning for historic resources.

The grants are leverage with a required 40% to 50% match.

Alaska has thirteen local governments certified as historic preservation partners with state and federal programs. The state's historic preservation program is led by the Office of History and Archaeology. The program annually receives a grant from the federal Historic Preservation Fund to carry out the programs identified in the 1966 National Historic Preservation Act. Ten percent of Alaska's award is for Certified Local Government (CLG) programs.

In addition, the Alaska Historical Commission seeks funds from private and public sources for special projects to help the state and local communities commemorate anniversaries. The availability of funds is advertised statewide with a call for project proposals.
