The furloughs will have minimal effects on service delivery both in and outside of the department as both of these days have always been popular dates for leave requests and have been managed well in the past.</p> <p>In the Administrative Services Division, the anticipated savings from these two mandatory furlough days will result in a savings of \$2.5 in FY2017.</p>
