Project Description/Justification:

This project will allow the Department of Public Safety to complete maintenance and repairs on its existing aircraft hangar facilities which are in need of structural, siding, electrical, and heating repairs. These hangars are a main support hub for the state to provide many mandated and essential public safety functions, primarily in rural Alaska.

These aircraft hangars protect the state’s valuable aircraft and other assets, such as snow machines and all-terrain vehicles (ATV’s), from the elements that otherwise could delay public safety response

time due to ice and snow pack or damage. The hangars provide safeguard to aircraft and equipment during storms and blizzards when it is unsafe for employees to check on tied-down aircraft. Extreme weather conditions can cause significant damage to aircraft and these hangars help ensure the protection and readiness of these assets.

Currently, the state operates out of several 30-plus year-old hangars in Kodiak, Bethel, Coldfoot, and Kotzebue. The Bethel hangar's main support beams are on pilings that have shifted so much over time it has caused them to twist and buckle. The concrete flooring is crumbling and in some places it is so weak it can be chipped with a bare hand. The state keeps four aircraft and search and rescue equipment in this hangar. There is inadequate space for storage of fuels, oils, and miscellaneous parts that accompany this fleet of aircraft. The existing hangar is structurally damaged and lacks many basic features such as compressed air and water. In both Kodiak and Kotzebue, the metal siding on the hangars has severely rusted and is leaking through the roof and walls. As a result, the insulation is ineffective and non-efficient due to water damage. The electrical lighting in both hangars is old and not-energy efficient and should be updated with much brighter and efficient lighting. The Coldfoot and Kotzebue hangar doors need repairs and straightening, due to shifting from years of use.
