**Brief Summary and Statement of Need:**

The Anchorage Metropolitan Planning Organization (MPO) selects surface transportation improvement projects, except on the National Highway System, for receipt of federal highway funds within the Municipality of Anchorage. This process results in an approved Anchorage Metropolitan Area Transportation Solutions (AMATS) Transportation Improvement Program (TIP) which prioritizes and describes the capital projects to be funded in the coming years, and is the leading program that implements the Anchorage and Eagle River Long-Range Transportation Plans.

**Project Description/Justification:**

A new TIP for federal fiscal years 2015 – 2018 has recently been approved and incorporated into the Statewide Transportation Improvement Program (STIP). The program amount for AMATS in FY2016 is \$32 million.
