Component: Central Design and Engineering Services

Contribution to Department's Mission

Develop projects that improve Alaska's transportation and public facilities infrastructure. The division also provides a wide range of technical services to the department, other state and federal agencies, local governments, utility companies and the public.

Core Services

- Develop capital improvement projects from the planning stage to final preparation of plans, specifications and estimates for construction advertising including survey, preliminary design, environmental, traffic and safety, materials, right-of-way, utilities, and design elements.
- · Provide technical assistance during construction.
- Assure environmental services during construction to help ensure compliance with permits and project commitments
- Complete and maintain airport master plans, airport layout plans and airport certification documents.
- Provide design input for all airport leasing actions.
- · Complete traffic studies and accident analysis.
- Conduct hydrological studies, materials exploration and testing, and surveying.
- Process utility, right-of-way and traffic permits to other state and federal agencies, local governments and the public.

Major Component Accomplishments in 2015

- Managed 239 projects (85% highway and 15% aviation) in various stages of development.
- Delivered a \$323 million program (85% highway and 15% aviation) of bid ready designs and contract documents. Representative projects delivered include the Glenn Muldoon Interchange Improvement project, Parks Hwy. MP 44.5-48.8 Reconstruction; Pavement Preservation projects on Fairview Loop, International Airport Road, Old Seward Hwy, Raspberry Rd., Willow Fishhook Road, and on the Glenn Hwy, safety projects included the Highway Safety Improvement Program (HSIP): Bragaw at 16th channelization, Central Region (CR) flashing yellow arrows ITS, HSIP: CR High friction Surface Treatment, HSIP Kodiak Rock Fall Mitigation, and erosion response projects on the Glenn & Sterling Hwy and aviation projects (Hooper Bay Airport Improvements, Adak Runway Safety Improvements, Talkeetna Airport Improvements).
- Issued 1,010 permits for driveways, approach roads, utilities and other right-of-way encroachments.

Key Component Challenges

- Increased volume of right-of-way acquisitions needed for larger corridor projects (including Seward Highway Dimond Blvd to Dowling Road (Rd), Glenn Highway 34-42, Parks Highway Church to Big Lake) is exceeding the component's ability to deliver, resulting in delays to construction.
- Lack of sufficient staff in federal agencies to issue permits and conduct reviews for construction projects.

Significant Changes in Results to be Delivered in FY2017

- Results Based Budgeting will be used to develop performance measures that quantify outcomes (not activities) as well as determine priorities.
- Preconstruction activities over this next year for several large projects (including Seward Hwy 75-90, and Sterling Hwy 60-79) will shift federal National Highway System resources from a pavement preservation focus to reconstruction.
