Component: Fisheries Taxes**Contribution to Department's Mission**

Distribute state funded Shared Fisheries Business Tax and Fisheries Resource Landing Tax to municipalities.

Major Component Accomplishments in 2016

The division administered the distribution of \$1,720,492.52 in Shared Fisheries Business Tax and Fisheries Resource Landing Tax funding to 98 communities.

Key Component Challenges

The Shared Fisheries Business Tax Program was created in 1990 to help municipalities impacted by the effects of the offshore fish processing industry. The Department's program extends the Department of Revenue's tax sharing program to include the sharing of fish taxes collected outside of municipal boundaries. Because tax revenue is generated from mobile processing facilities, primarily from floating fish processors, the amount of shared tax varies from year-to-year.

Significant Changes in Results to be Delivered in FY2018

No significant changes to component.
