Project Description/Justification:

This project supports the receipt of two specific grants from the U.S. Department of Homeland Security. State Homeland Security Program (SHSP) is funded to support State and local efforts to prevent terrorism and other catastrophic events. It requires 80% of the funding be passed through to local units of government, and not less than 25% of the funding is used for law enforcement terrorism prevention activities. SHSP funds are allocated based on eligible equipment or activities, and based on Alaska's priorities developed through the Threat and Hazard Identification and Risk Assessment (THIRA) program. Funding is used for equipment acquisition and deployment, development of homeland security and/or emergency management plans, and training and exercises for first responders. There is no state cost-share required for SHSP.

The Pre-Disaster Mitigation (PDM) Grant Program provides resources to assist states, tribal governments, and local communities in efforts to implement a sustained natural hazard mitigation program. A portion of the funding is provided to update or develop hazard mitigation plans for the State and local jurisdictions. The remainder is nationally competitive for hazard mitigation projects. PDM funds are allocated based on federal appropriations and priorities developed through the State of Alaska Hazard Mitigation Plan. PDM requires a 25% non-federal cost-share, funded by local jurisdictions for competitive projects or through funds from State disaster declarations.
