The Exxon Valdez Oil Spill Trustee Council is proposing to fund the purchase of two adjacent parcels of land totaling approximately 184 acres in the Prince William Sound Port Valdez area. The property is adjacent to the Valdez ferry terminal, would provide access to help connect with existing trails in the immediate area, and is near the outlet of a salmon stream. The purchase is being negotiated with the private landowner. Legislative approval is needed in order to complete the purchase.

**Project Description/Justification:**

The parcels proposed for purchase, known locally as Meals Hill, rank in the highest priority category for their habitat values for multiple fish and wildlife species. The protection of the Meals Hill property also would benefit recreational and tourism opportunities in Valdez by securing enhanced public access to a unique, locally accessible coastal property with existing trails and within walking distance from the ferry terminal, small boat harbor and downtown Valdez. The EVOS trust fund monies made available for this purchase have strict guidelines governing their use for habitat protection and public recreation. Legislative approval to expend trust fund monies is needed in order to complete the purchase.

**Accomplishments:**

Purchase of the Port Valdez parcels would ensure permanent habitat protection for spill impacted species that utilize the coastal forest and adjacent nearshore habitats and would help fulfill the restoration purposes of the EVOS Trust Fund. The purchase would also create new recreational and
