This project will fund the construction of five new public use cabins in high demand areas, satisfying the public demand for cabins and providing the Division of Parks and Outdoor Recreation with increased revenue from rental fees.

**Project Description/Justification:**

In developing locations for public use cabins, The Division of Parks and Outdoor Recreation will work with regional superintendents, local park advisory boards, and park management plans. The five public use cabins will be strategically deployed throughout the state in high volume areas to address demand and provide reliable revenue. High recreational use areas and existing facilities will also be included in the evaluation for cabin placement. Additionally, the public and local stakeholders will be given opportunities to provide input to park staff and their advisory boards.

Public Use Cabins (PUCs) are in increasingly high demand by Alaskans and visitors. Particularly, demand for PUCs that are ADA accessible, on the road system and close to major population centers has grown significantly in recent years; cabins built in the last five years meeting these criteria are among the busiest in the park system.

Public use cabins are utilized by traditional park system users, and additionally encourage different market segments to utilize the park system. PUCs are considered a low impact entry to camping for those who would not otherwise do so, thus increasing park usership and encouraging different demographics to use the parks.

By private sector standards, PUCs are considered a sound investment. Utilizing a conservative estimate of 45% yearly occupancy, PUCs pay for themselves in just under five years and require little to no maintenance costs. The system's top 10 most popular cabins have an average occupancy rate of 54% and new cabins would be strategically located for a yearly occupancy goal of above 50%.

Making this initial investment will provide services to the public that are in high demand and a revenue source to the division that would continue to make state park operations more sustainable and decrease the general fund dollars used to fund the system.
