Monetary terms of the July 1, 2018, to June 30, 2021, Collective Bargaining Agreement

between the State and the Alaska Public Employees Association – Supervisory Unit.

The Administration concluded the negotiations process with the Supervisory Unit. If approved by the Legislature the monetary terms of this agreement become effective July 1, 2018, and remain in effect through June 30, 2021.

I. Terms Requiring Appropriation

Current Legislative session

Effective July 1, 2018, all employees will have a forty (40) hour work week and shall be paid for those hours.

Effective January 1, 2019, the Employer's health insurance premium contribution will be the amount of money not exceeding that necessary to maintain the Select Benefits Default/Economy plan less a monthly employee contribution not to exceed 10% of the premium contribution.

II. Change in State Revenues

Effective January 1, 2020, the Employer's health insurance contribution rate shall be the amount of money not exceeding that necessary to maintain the Select Benefits Default/Economy plan less a monthly employee contribution not to exceed 12% of the premium contribution.

Effective January 1, 2021, the Employer's health insurance contribution rate shall be the amount of money not exceeding that necessary to maintain the Select Benefits Default/Economy plan less a monthly employee contribution not to exceed 15% of the premium contribution.

Employees hired on or after July 1, 2018, will pay higher rent when living in State Owned/Controlled Housing units.

III. Change in Productive Work Hours

Every full-time employee will have a forty (40) hour work week.

Every permanent full-time employee will be required to take sixteen hours of furlough in the first year of the agreement.

Employees within five years of retirement may elect to forfeit 22.5 hours of leave in lieu of furlough.

IV. Terms addressing employee compensation, not requiring appropriation Effective July 1, 2018, employees at pay increment "P" and beyond will be required to serve three years at each pay increment rather than two years.

This report of monetary terms is consistent with the requirements of the Public Employment Relations Act. Please forward these monetary terms to the Legislature in accordance with AS 23.40.215.

FY2019 Operating Budget Amendment

Amend section 22(a) to read:

- * Sec. 22. SALARY AND BENEFIT ADJUSTMENTS. (a) The operating budget appropriations made in this Act include amounts for salary and benefit adjustments for public officials, officers, and employees of the executive branch, Alaska Court System employees, employees of the legislature, and legislators and to implement the terms for the fiscal year ending June 30, 2019, of the following ongoing collective bargaining agreements:
 - (1) Alaska State Employees Association, for the general government unit;
 - (2) Alaska Vocational Technical Center Teachers' Association, National Education Association, representing the employees of the Alaska Vocational Technical Center;
 - (3) Confidential Employees Association, representing the confidential unit;
 - (4) Public Safety Employees Association, representing the regularly commissioned public safety officers unit.

(5) Alaska State Employees Association, for the supervisory unit;

(b) If a collective bargaining agreement listed in (a) of this section is not ratified by the membership of the respective collective bargaining unit, the appropriations made in this Act applicable to the collective bargaining unit's agreement are adjusted proportionately by the amount for that collective bargaining agreement, and the corresponding funding source amounts are adjusted accordingly.
