- Provides victim-witness assistance services such as: information on court procedures required by statute and the
 Alaska Constitution; applying for restitution; arrangement of travel and payment for expenses and court-mandated
 witness fees; assistance with domestic violence orders and violent crimes compensation procedures; and
 preparation of victims and witnesses to testify in court.
