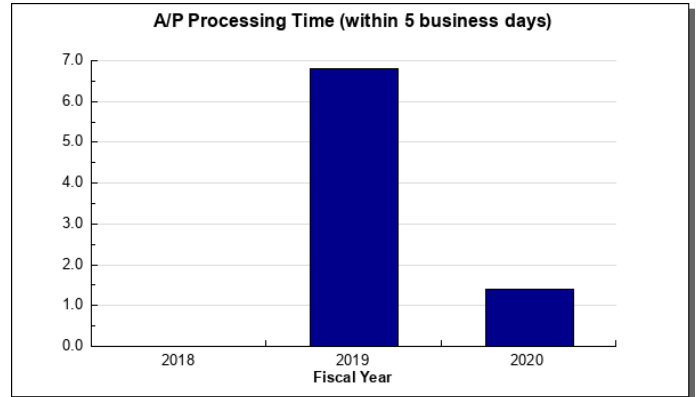

Major Department Accomplishments in 2020

- Implemented various measures in response to the COVID-19 pandemic that provided State of Alaska (SOA) employees with superior telework access and capabilities. This included rolling out Microsoft Teams to approximately 8,000 employees, upgrading the state’s virtual private network controllers that increased the number of simultaneous connections from approximately 1,500 to approximately 20,000 and coordinating three emergency laptop purchases of over 4,300 devices.
- At the request of the Administration, developed and implemented the Pandemic Preparedness Plan (PPP) to ensure worker health, safety and continuity of services to the SOA. The Department of Administration (DOA) assessed and analyzed how the SOA can modify tasks, services and business processes so they can best be performed from home offices in a telecommuting environment. DOA also implemented the Pathway project to implement a modified performance system to prepare personnel, supervisors and leadership for managing performance, improving outcomes and recruiting and retaining high performers in a telecommuting workplace environment. DOA is also implementing technology like a Service Management System, digital Performance Management System/Learning Management System and cybersecurity upgrades to develop the electronic infrastructure necessary to support a telework workforce.
- Successfully launched the Alaska Administrative Productivity and Excellence (AAPEX) initiative, which included assessment of the effectiveness of information technology (IT) and Back-Office Shared Services and defining, designing and planning remaining IT and Back Office Shared Services improvements. It is implementing a statewide Information Technology Governance charter to address statewide standards in IT architecture, equipment, security, services and new technologies. This will achieve consolidated services, greater transparency, cost savings and customer satisfaction for Shared Services and IT for SOA Departments.
- Produced cost savings as well as cost avoidance, despite the partial state of consolidation in the Office of Information Technology (OIT) by starting to eliminate duplication, migrating computing resources to shared datacenters and reducing licensing costs throughout the SOA Departments. In response to the pandemic, OIT reacted rapidly to provide enough remote access to stay well ahead of demand for telework. OIT also provided collaborative tools and e-Signature software in a matter of weeks. OIT continues to implement nearly a dozen major initiatives to provide the foundation for a secure and high functioning remote work environment.
- Established the Office of Procurement and Property Management (OPPM) and began the consolidation of Statewide Procurement. Through a collaborative and transparent change management and communication strategy, OPPM has been able to move aggressively forward with procurement consolidation. In less than twelve months, since the start of an initial best strategy as developed within the AAPEX initiative, OPPM has transitioned employees in four state departments and plans to transition the rest of the SOA Departments by July of 2021. OPPM’s property management component has also been highly successful in generating revenue for the State.

- Began the migration to the Cloud, which will result in significant security protections on the network and cost savings for IT servers. Cloud migration will allow the SOA to achieve cost savings by paying for what it actually consumes, instead of buying excess capacity to handle spikes in usage. The SOA will also be able to create storage and computing capability without purchasing new hardware, provide dynamic disaster recovery by easily locating back-ups in diverse locations and secure data in environments that maintain the strictest compliance to federal security standards.
- Launched the upgrade of the State of Alaska accounting system, Integrated Resource Information System (IRIS). IRIS must upgrade to the newest version of CGI Advantage® 4.0, described as the largest release in over a decade. This upgrade is scheduled for completion in FY2021. The 4.0 release offers enhanced functionality, improved user interface and updated technology stack.
- Continued on-going efforts in centralization of back-office accounting functions within Shared Services of Alaska (SSoA) and information technology functions within the OIT.
- Streamlined processing in accounts payable (A/P) and travel services resulting in cutting transaction cycle times by 66% in A/P and 85% in travel expense processing, expanded services and increased documents processed by 25%, and reduced the interagency document rate chargeback by 22%.
- Completed negotiations of successor agreements with the Inlandboatmen's Union of the Pacific, which involved managing the first marine strike in over 40 years, Alaska Vocational Technical Center Teachers' Association and two separate contracts for the Department of Public Safety and Department of Transportation components of the Public Safety Employees Association.
- Successfully planned and implemented the statewide conversion to bi-weekly payroll, which will result in reduced costs by running two fewer payrolls each year and an easier transition to the SOA accounting system; IRIS 4.0 upgrade.
- Implemented various cost savings measures in the AlaskaCare active employee medical plan, including unprecedented open-access hospital and facility network agreements, targeted programs for high-cost specialty medications, and advantaged pharmacy pricing with OptumRx.
- Implemented targeted cost saving measures in the AlaskaCare employee health plans that have allowed the Division of Retirement and Benefits (DRB) to reduce the Standard medical plan premiums, keep all other premiums flat and maintain the employer contribution for health care coverage, all without reducing benefits.
- Spearheaded the renegotiation of hospital contracts in the Municipality of Anchorage and as a result AlaskaCare employee health plan members will have more options for network hospitals and facilities beginning in 2021. Both Alaska Regional Hospital and Providence Alaska Medical Center will be in-network for AlaskaCare members, along with many free-standing surgical centers. This unprecedented open-access network model will provide more choices and reduce costs for members seeking health care services in the Anchorage area.
- Transitioned from in-person seminars and counselling sessions for the State of Alaska and Empower Retirement in Juneau and Anchorage to on-line and phone-based appointments, due to covid-19. To accomplish this, DRB transitioned the counselling team to telework and expanded the availability schedule, all without an increase in cost or a decrease in responsiveness to members.
- Drastically increased the number of class A and unclassified felony cases that are processed within the Office of Public Advocacy (OPA), as opposed to being contracted to outside attorneys to reduce criminal contractor expenses.
- Launched the State Open Data Portal which contributes to the pandemic preparedness of the SOA by providing increased use of digital sharing of information between agencies and the public. This new environment also contributes to the Governor's call for more transparency in government.

- Awarded the Government Finance Officers Association (GFOA) “Certificate of Achievement for Excellence in Financial Reporting” for both the Public Employees’ Retirement System (PERS) and Teachers’ Retirement System (TRS) for FY 2019 Comprehensive Annual Financial Reports (CAFR).
- Received an award from the National Association of Government Defined Contribution Administrators for outstanding achievement in Participant Education and Communications.

Key Department Challenges

COVID-19 Pandemic - The COVID-19 pandemic has strained Department of Administration’s (DOA) budget, staff and infrastructure resources. DOA is working to respond and adjust to COVID-19 and to recover and prepare to thrive in the future of telework. It has and continues to quickly augment operations to respond to the impacts of the COVID-19 pandemic to keep State of Alaska (SOA) employees safe. It is expanding telecommuting capabilities, staggering schedules, modifying buildings’ air intake, drafting statewide policies and communications and ensuring flexibility and adaptability without diminishing service delivery or employee performance.

Initiatives - DOA has undertaken several initiatives at the direction of the Administration, either directed by Administrative Order (AO)(consolidations) or directly, like the Pandemic Preparedness Plan (PPP). These initiatives require significant change for departments, which is hard. DOA’s challenges in ensuring the successful implementation of these initiatives include: a) having sufficient internal resources to manage the projects and change management necessary for each effort, b) receiving budget support to ensure success as the transitions launch, and c) receiving support from departments, Office of Management and Budget (OMB) and Governor’s Office leadership as we move forward together to stabilize these transitions.

Office of Information Technology (OIT) - An ongoing challenge for OIT is the incomplete implementation of information technology (IT) consolidation. This incomplete implementation is being addressed with a full reconciliation of IT roles and responsibilities needing to be completed. The full value of IT consolidation cannot be realized until IT spending (approximately \$270 Million across the SOA) is consolidated into OIT and centrally managed. Upon consolidation, the SOA will achieve significant cost savings from consolidated IT. Currently, OIT has about \$70 Million in spending, most of which is for personnel.

In order to protect the integrity of the SOA network, AO 284 directed that the Chief Information Officer (CIO) with the assistance of the Chief Information Security Officer (CISO) oversee information security policies and practices within all executive branch agencies. Executing this responsibility continues to be a challenge based on the incomplete IT consolidation, particularly cyber security. OIT and the State Security Office (SSO) continue to have limited access to agency applications and network elements and lack recognized authority over information security functions across executive branch agencies.

Another notable challenge is to develop a beneficial way to train application and infrastructure teams, on how to use cloud services as well as assessing the cost and resources needed to modernize aging state applications for cloud adoption.

Division of Personnel and Labor Relations (DOPLR) - DOPLR will be negotiating 10 of the 12 union contracts between now and next fall and faces a risk that some of these negotiations may be adversarial.

Office of Public Advocacy (OPA) - OPA continues to sustain heightened levels of new cases. At the same time, OPA’s cases are no longer closing at the same rate, which is leading to a rapid caseload growth. It is anticipated caseload numbers will remain high as a result of the COVID backlog the Court System is experiencing. Simply put, cases are not resolving although new cases continue to come in. Additionally, due to a rule enforcement change from the Social Security Administration (SSA), OPA has become the primary agency to absorb 800 SSA rep payee cases. This puts a significant strain on OPA’s resources.

Health Plans – The Division of Retirement and Benefits (DRB) continues to strive to improve health plans while continually working to reduce costs. This includes identifying and implementing best practices in vendor management regarding administration of the health plans and developing more capacity, additional expertise and sophistication in health care related positions. DRB is working to develop and expand the Preferred Provider Network in key geographic areas of the state and improve vendor management of cost containment methods for high cost claimants.

It continues to develop and implement innovative value-based payment models and monitors, analyzes and implements health systems for compliance with Health Information Technology for Economical and Clinical Health/Health Information Portability and Accountability Act requirements and other federal health care legislation. DRB must revise and update as necessary the current active and retiree health insurance plan booklets as well as examine the health eligibility process, identify systemic errors and collaborate with external stakeholders to correct those systemic errors.

Integrated Resource Information System (IRIS) Upgrade – The SOA accounting system (IRIS) is approaching end of life and it must upgrade to the newest version of CGI Advantage® 4.0. This critical and major upgrade will require significant strategic planning work, new hardware, testing, training, documentation and organizational change management to ensure a successful implementation.

Significant Changes in Results to be Delivered in FY2022

Division of Personnel and Labor Relations - Human Resource (HR) Transformation will be normalized. 57% of identified HR process inefficiencies can be resolved through process standardization. HR will be adding 7 new business function services never before offered to State of Alaska (SOA) Departments to improve customer satisfaction.

Shared Services of Alaska (SSoA) - SSoA Accounts Payables and Travel are anticipated to have all departments fully onboarded, resulting in maintained or reduced rates and processing times.

State of Alaska Procurement Consolidation – SOA is consolidating procurement functions by moving procurement staff from other SOA departments to the Office of Procurement and Property Management (OPPM) in FY2022. This consolidation requires establishing best practices and training for incoming staff to ensure consistent procurement processes are followed and data collection geared toward process improvement and State spending practices will be readily available for analysis. Close participation by agency administrative staff is vital to ensure all resources are in place and delays are minimized.

Consolidated Procurement will result in cost savings by centralizing State procurement and property management employees to allow optimal personnel resource distribution across the state. Duplication of spend and the reduction of personnel resources allotted to duplicating comparable Requests for Proposals and solicitations will be minimized resulting in both hard and soft savings to the state's holistic purchasing power to obtain best value for common supplies and services. OPPM will take a leadership role to leverage department spend and look for sources to meet the State's need at the lowest cost coupled with the best services and/or supplies.

Office of Information Technology (OIT) – Consolidated OIT will bring several million in reduced information technology (IT) contract spending across the SOA enterprise. Savings will be driven by standardized equipment, consolidated IT procurement of software and licensing as well as identification of duplication across the state agencies. OIT will take a leadership role in coordinating agency requirements as well as validating vendor spend.

The completion of cloud migration, maturing statewide IT governance, fiscal transparency and completion of the consolidation envisioned in Administrative Order 284 is targeted to be completed by the end of FY2022. The remainder of consolidation efforts will be driven by the deliverables provided as part of the Commissioner's Alaska Administrative Productivity and Excellence (AAPEX) initiative.

Telework - Telework will be robust. By developing and maintaining a well-developed and strong telework infrastructure, in FY2022 departments can assess their use of space, determine how to reduce office use and determine if there are leases they can terminate as a result of telework.

IRIS Upgrade – The SOA accounting system, Integrated Resource Information System (IRIS), upgrade is currently in process. This will continue throughout FY2021 and conclude in the second half of FY2022. The upgrade is essential to ensure the IRIS system continues to function effectively, to utilize new features that improve productivity, to resolve known issues and defects in the software and to ensure the version continues to be supported. This change means an improved user interface, new functionality and updated technology stack for IRIS.

Vehicle Registration Modernization – The Division of Motor Vehicles (DMV) is continuing its efforts to obtain more

efficient and cost-effective solutions to issue license plates and tabs. Options range on a spectrum from continuing to issue physical inventory out of DMV offices, to implementing a just-in-time inventory. DMV will implement a combination of these options with new contract(s) in place by April 2021; with full implementation completed by the beginning of FY2022.
