Department of Education and Early Development Residential Schools Program Component Budget Summary

Component: Residential Schools Program**Contribution to Department's Mission**

To provide reimbursement to school districts that provide boarding arrangements for secondary students who do not have daily access to the appropriate grade level at their local school. To provide funding to seven existing statewide residential programs serving grades nine through twelve for reimbursement of eligible transportation, and room and board costs.

Core Services

- The Boarding Home Program provides grant funds to school districts serving high school pupils who do not have access to a high school program where they reside. Costs for boarding care and transportation to and from the boarding home are paid for by the Boarding Home Program; 4 AAC 09.050. Reimbursement is made to the local provider's district.
- The Residential School Program supports residential schools located in Anchorage, Bethel, Galena, Kotzebue, Nenana, Nome, and Utqiagvik (Barrow). This program allows for both statewide and district-wide schools as well as variable-length or 180-day school terms.

Major Component Accomplishments in 2020

- The Boarding Home Program made distributions in FY2020 for one student in the Yukon Koyukuk School District, but there are several communities in Alaska that do not have a K-12 facility, so it is expected that as students in those communities reach the 11th and 12th grades they may participate in this program;
- The Residential School Program supported approximately 457 students in seven programs located in Anchorage, Bethel, Kotzebue, Galena, Nenana, and Nome; and
- Two new residential school programs were approved in the Lower Yukon and North Slope Borough School Districts; however, neither district reported any students in FY2020.

Key Component Challenges

Continuing to provide educational services and room and board to secondary-age children in the boarding homes and residential schools in cost effective ways.

Significant Changes in Results to be Delivered in FY2022

There are no significant changes in results to be delivered in FY2022.

<p>Anchorage School District was approved for a residential program and funding was appropriated for them starting in FY2015 with a count of four beds (\$45.6). Since approval, Anchorage School District has never claimed any students during the count period, thus never receiving a reimbursement. The Department has been in contact with Anchorage School District on multiple occasions over the past few years, but aside from the following response in their FY2016 Year-End Report the Department has not received further confirmation on whether or not the district is or is not still operating this residential program.</p> <p>"Plans for this residential school never actualized. The Anchorage School District has no plan for implementation of the program during the current (2016-2017) school year, nor is there any plan to start it in any future school year."</p> <p>Eliminating the approval for this program means a savings of \$45.6 UGF to Residential Schools Program which continues to lapse each year.</p>
