Component: National Forest Receipts**Contribution to Department's Mission**

Distribute federally funded National Forest Receipts financial assistance to eligible recipients.

Major Component Accomplishments in 2021

Administered the funding disbursement of \$7,700,219.91 in Secure Rural Schools Receipts to 34 communities and school districts.

Key Component Challenges

The Secure Rural Schools Act (SRS Act) was last reauthorized by Congress in the Further Consolidated Appropriations Act, 2020, which was signed on December 20, 2019, and authorized payments for federal FY2019 and FY2020 / state FY2020 and FY2021. Funding for the SRS portion of the program is subject to federal appropriation.

If the SRS program is not federally reauthorized for federal FY2021 / state FY2022, Alaska will receive approximately \$600,000 in National Forest Receipt revenue under the 1908 Act. This would be a significant decrease from recent distributions.

Significant Changes in Results to be Delivered in FY2023

If the SRS program is not federally reauthorized for federal FY2022 / state FY2023, Alaska will receive approximately \$600,000 in National Forest Receipt revenue under the 1908 Act.
