Brief Summary and Statement of Need

Funding for preliminary (predevelopment) activities necessary for the development of independent and assisted-living housing units for seniors. Activities may include:

- Preparation of plans and specifications;
- Project feasibility studies;
- Appraisals; and
- Other pre-development activities.

Program Description and Justification

SCHPP provides grant funds to municipalities, public or private non-profit corporations, and regional housing authorities in conjunction with other agencies to fund planning activities necessary for the development of senior housing.

One of the strategies of the Mental Health Trust Authority is to provide comprehensive services for seniors and individuals with disabilities. This funding will help address this need through planning and predevelopment activities that develop the capacity of the state to provide effective assisted living housing to Alaska's rural elders/seniors.

Projected Outcomes

- Completion of predevelopment activities designed to improve the inventory of elder/senior assisted living facilities; and
- Increased capacity of Alaska's assisted living providers to address housing and supportive services needs of rural elders/seniors.
