Brief Summary and Statement of Need:

The Division of Retirement and Benefits (DRB) is in the final stages of an information technology (IT) modernization project to replace the antiquated Computerized Retirement System (CRS) with an expanded, fully-functional, and modern Benefits And Retirement System (BEARS). During the development of BEARS, DRB received a Supreme Court decision (State of Alaska vs. Metcalfe), and identified other items requiring changes to programming outside the original scope of the project. A second phase of the project is required to accommodate those changes.

Project Description/Justification:

In FY2019, the DRB was allocated \$30,000,000 for an IT modernization project (BEARS). Design and development is nearing completion and is scheduled to be implemented in December 2024. Additional funding is needed to provide necessary changes to BEARS to comply with the *State of Alaska vs. Metcalfe* Supreme Court decision and provide additional enhancements identified during BEARS development but were originally out-of-scope. Design, development, and implementation of enhancements are anticipated to be completed in FY2028. Funding for enhancements will ensure

that DRB can process required changes accurately and timely. Enhancements will also allow DRB to accommodate direct billing of health plan members, resulting in cost savings for the DRB as it will eliminate a substantial portion of costs paid to PayFlex, DRB's health plan billing vendor. Additionally, these enhancements will be integrating the contact center workflow and counseling scheduling functions, streamlining various DRB workflows. This will result in reduced processing timeframes for member retirements, refunds, etc. and simplify the process of potential future system updates.
