Conduct lead abatement cleanup at the closed shooting range located in the Hiland Mountain Correctional Center in Eagle River. The Department of Corrections (DOC) has been working with the Department of Environmental Conservation (DEC) and Environmental Protection Agency (EPA) to address lead abatement requirements and responsibilities.

**Project Description/Justification:**

The Code of Federal Regulations (CFR), 40 CFR Part 265, Subpart G. 40 CFR Section 265.112, requires the owner or operator of a shooting range no longer in operation to submit a site closure plan 180 days prior to the date of the expected closure. Further, the expected closure is 30 days from the date when the final volume of hazardous waste was received or one year after the date of the most recent volume of hazardous waste was received.

EPA requires a compliant closure plan. Once EPA approves the closure plan, DOC will be required to implement the plan and abate in accordance with the approved schedule and provide certification to EPA that the work was completed in accordance with the approved plan.

Funding for this project will provide DOC with the ability to meet federal requirements and avoid any penalties or fines for non-compliance.
