Civil Division Results Delivery Unit

Contribution to Department's Mission

Provide high-quality legal representation to executive branch agencies for the benefit of all Alaskans.

Core Services

- Protecting the safety and physical and financial well-being of Alaskans.
- Asserting the state's resource management rights for maximum sustained use consistent with the public interest and revenue protection.
- Promoting good governance.
- Provide high-quality legal defense representation when the state is sued with the goal of mitigating the state's legal and financial risks.

Major RDU Accomplishments in 2023

Protecting the safety and physical and financial well-being of Alaskans

- The Civil Division handled:
 - 200 child support cases
 - 54 Forcible Entry and Detainer cases for Alaska Housing Finance Corporation
 - 100 guardianship and conservatorship hearings
 - More than 2,000 mental commitments that were filed statewide
 - 50 administrative hearings
 - Supreme court appeals
 - 32 Child in Need of Aid
 - 10 mental commitments
- The Human Services Section collected (as it has in the past few years) over two million dollars through the Medicaid subrogation, estate and trust recovery claims, and the Medicaid audit process, ensuring more money is available for vulnerable populations.
- The Regulatory Affairs and Public Advocacy Section appears before the Regulatory Commission of Alaska to advocate for fair rates in utility rates matters.

Asserting the State's resource management rights for maximum sustained use consistent with the public interest and revenue protection

- Assisted in passing Carbon Offset and Sequestration legislation as a priority of the Governor.
- The Civil Division continues to effectively manage the multi-year appropriation to cover the myriad of litigation where interests are adverse to the federal government, whether filed by the State or where the State is intervening, or in a defense posture. This allows the State to more readily utilize outside counsel and experts to ensure there is sufficient coverage to protect Alaska's interests.

Providing high quality legal defense representation when the state is sued with the goal of mitigating the State's legal and financial risks.

- The Civil Division represented the State and/or its employees in over 50 tort cases and 150 workers' compensation cases.
- The Torts Section and Workers' Compensation and Corrections Section also pursue aggressive motion practice, trial, or negotiation to contain costs associated with civil and administrative litigation filed by inmates against the Department of Corrections (DOC) and its employees. The section also represents the DOC and/or its employees in both civil and administrative matters. The four Attorneys in the Corrections Section currently have over 280 open matters.

Promoting and defending good governance

- Pursuant to legislation passed in 2022, Civil Division attorneys are actively participating and advising Department of Education and Early Development during negotiations with several tribes to establish a pilot program for tribal-compacting schools, and to produce a report to the legislature on that subject.
- The Civil Division completed and implemented a comprehensive review of the entire regulations process and identified improvements to provide for more efficient and streamlined promulgation of regulations. Those process improvements have been incorporated into the Drafting Manual for Administrative Regulations, resulting in significant improvements in the process and reducing the time for Civil to review regulations in many instances by months.
- The Civil Division represented various state agencies in dozens of administrative hearings related to occupational health and safety, procurement, and grants.
- The Civil Division advised and worked on over 100 public records requests for their department or other executive branch agencies.
- The Civil Division provided or participated in dozens of trainings for the executive branch related to
 - o Open Meetings Act
 - Ethics
 - Regulations
 - Fiduciary Duties
 - Public Records
 - o Procurement

Key RDU Challenges

Protecting children, vulnerable adults, and consumers is at the core of the Civil Division's mission to protect both the physical and financial well-being of Alaskans.

- The Civil Division has been and will continue to be involved in advising and representing the Department of
 Health and the Department of Family and Community Services in various complex matters, including a
 class action seeking systemic reform of the child protection system and various litigation related to the
 Supplemental Nutrition Assistance Program (SNAP) and Medicaid eligibility delays and the ongoing
 investigation alleging violation of the Olmstead decision (finding long-term institutional care to violate
 federal law) in how children with complex medical and mental health needs are treated.
- Child protection continues to be an area of concern. The caseloads are high and the opportunity for burnout among employees dealing with difficult material remains an issue.
- The Division is also focusing on vulnerable Alaskans though the emergency mental health system and the challenges currently facing the Office of Public Advocacy related to guardianship and conservatorships. Additional pressure relates to the need for improved forensic services in Alaska.

Asserting the State's resource management rights for maximum sustained use consistent with the public interest and revenue protection

- Between aggressive regulatory policy changes from the federal government and lawsuits by third party groups
 impacting Alaska's interests, it is difficult to keep up with every action that adversely affects the State. One way
 the Civil Division is addressing this is to partner more frequently with other aligned states on issues of national
 interest, letting the other states take the lead, and focus the State's limited legal resources on issues that are
 unique to Alaska.
- Due to the increase in federal issues, this has also strained legal resources for the day-to-day operational work in assisting the resources agencies.
- The Civil Division advises on the implementation of the newly enacted carbon offset/sequestration programs.
- The Civil Division advises on the implementation of Broadband expansion in Alaska.

The Civil Division advises in managing and administering federal infrastructure funds.

Provide high quality legal defense representation when the state is sued with the goal of mitigating the State's legal and financial risks.

 Despite some recent challenges with vacancies, the Torts Section, Workers Compensation and Corrections team has been very successful in meeting the increasing needs and demands related to their work. While still requiring some assistance from outside counsel, new matters are all being handled in house, and the division does not expect that to change over the coming months.

Promoting and Defending Good Governance

- The division has seen a significant increase in both the volume and complexity of public records requests for
 records of the department but also in advising the executive branch agencies on public records matters. The
 department responds to and advises on dozens of public records matters every fiscal year.
- Additional time and effort will be required in the coming year to advise on cybersecurity, Information Technology
 (IT) privacy and confidentiality, data security rules, and Artificial Intelligence. These issues are all highly technical
 and complex and developing in-house expertise to advise the executive branch on these issues is critical.
- Increased efforts to meet the needs of the administrator to achieve their policy initiative will require additional
 resources to support the legislative and regulatory needs of the executive branch. The volume of requests are
 outpacing the internal resources, and to meet statutory deadlines as well as other deadlines will require additional
 resources.
- Calendar year 2024 is both a state and federal election year. The division anticipates, as in other election years, significant litigation. As in other years, the division will create an election team to handle the agency advice, the civil litigation, and any appeals that might be filed in state or federal court. This team will be assigned to election work in addition to their present caseload, noting that most election work is managed on an expedited basis.

Significant Changes in Results to be Delivered in FY2025

As the Civil Division continues to rebuild, there will be increased focus on how to effectively onboard and train attorneys to ensure they can perform at their optimal level. In some instances, the Civil Division appears to be stabilizing in its vacancy rate; however, challenges remain in Child Protection, Oil and Gas, and in seeking attorneys with significant litigation experience as well as subject matter experience (procurement and IT). Using more targeted recruiting efforts and utilizing a legal recruiter agency, the Civil Division hopes that by FY2025 there will be fewer vacancies, higher retention rates, and more depth in experience across the sections.
