Project Description/Justification:

Numerous federal and private foundations incorporate a matching cash contribution requirement in their competitive grant programs. The grant match program has been vital to attracting outside funding into Alaska to meet the housing needs of these vulnerable populations.

This program allows AHFC to apply for and receive federal, State, and other grants that target the housing needs and supportive services of people with disabilities, victims of human trafficking, low-income households, rural professionals, and homeless Alaskans. AHFC competitively awards federal funds received, as well as match funds, to local non-profit or municipal sub-grantee agencies

who deliver housing and related supportive services. Examples of programs with match components include HUD Supportive Housing, Housing Opportunities for Persons with AIDS, the U.S. Department of Agriculture (USDA) Housing Preservation Grant program, HUD Section 811 program, and the Department of Justice Housing for Human Trafficking Survivors program.

AHFC may use the authority available under this program to apply to private institutions or foundations to address issues such as housing delivery systems, safe and viable neighborhoods, homelessness, and aging in place.
