Brief Summary and Statement of Need:

Provide assistance to local winter trail grooming organizations to maintain a well-groomed trail system for utility and recreational uses by snow machiners, skiers, dog mushers, and other winter trail users. Funds for this program are provided by snow machine registration fees paid by Alaskans and are distributed in the form of grants for trail development and maintenance, trail marking and signing, and safety education. These funds may be combined with federal surface transportation block grants set aside in 23 USC 133(k) to further enhance winter trail grooming activities throughout the state.
